Why Assets Matter

Assets provide the means to weather the inevitable financial setbacks we all endure, while offering hope and opportunity for a better future. They allow families to strive toward the goal all Minnesotans share: to achieve financial stability and prosperity.

Why Asset Building Strategies Are Important

Nearly one in four Minnesota families are unable to meet basic needs for three months if a bump in the road – like a job loss or a health crisis -- causes a sudden and unexpected reduction in income. These families are "asset poor." Moreover, hundreds of thousands more not only have insufficient assets, but also have insufficient means to just get by week to week.

Our Vision for the Minnesota Asset Building Coalition (MABC)

The MABC is a broad-based coalition that unites financial asset-building practitioners and advocates across the cultural and geographical breadth of our state to inform and engage policymakers to make the most effective investments in asset building for our shared future. Asset building programs and policies (1) help Minnesotans learn to become financially literate; (2) provide opportunities to earn a sufficient amount to support a family through family supporting employment and tax credits; (3) foster saving and investment to acquire assets like a home, a college fund or retirement account; and (4) protect acquired assets from predatory financial practices. Policies providing the opportunity for more Minnesota families to build assets and climb the economic ladder lead to a stronger and more balanced state economy.
